- Personnel training and education so that they are fully aware of Company rules and procedures and, more generally, of the correct operating procedures for carrying out their respective tasks;
- Periodic monitoring of each process in order to identify weaknesses and determine the relevant improvements;
- Commitment of the Management to implementing and periodically reviewing the Management System, developed through continuous improvement.
